What is the overall deductible ?	No deductible	See the upcoming pages for your costs for services this plan covers.
Are there services covered before you meet your deductible ?	No	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	Prescription drug : Level 1 and 2: \$600 Individual \$1,200 Family Level 4: \$1,200 Individual \$2,400 family Durable Medical Equipment (in-network only): \$500 per individual	If you have other family members in this plan , the overall family out-of-pocket limit must be met. The out-of-pocket limit is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal maximum out-of-pocket is \$8,550 individual/\$17,100 family. This applies to all essential health benefits, including some services not included in the out-of-pocket limit . (i.e. certain level 3 & 4 prescription drugs and adult hearing aids covered under this plan).
What is not included in the out-of-pocket limit ?	Copayments for Level 3 and Level 4 non-preferred specialty drugs , coinsurance for adult hearing aids, premiums and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
