Changes to your Quartz health plan

Thank you for choosing Quartz through the State of Wisconsin Group Health Insurance Program. This letter includes plan updates and what you can expect as a Quartz – UW Health member.

Your open enrollment period

“It’s Your Choice” open enrollment is September 26 – October 21, 2022. Visit ChooseQuartz.com for information about coverage and network options, or call a Quartz representative at (844) 644-3455.

Summary of 2023 changes

The following changes to the group health insurance program take effect on January 1, 2023:

- Health plans may waive prior authorization for remote patient monitoring when appropriate.
- Separate behavioral therapy sessions for a patient’s immediate family will be allowed as part of an ongoing mental health and substance use disorder treatment plan.

Provider network updates

The Quartz – UW Health provider network continues to offer primary and specialty care access throughout Dane County (except within the communities of Cambridge, Marshall, and Mazomanie).

All Quartz members must choose a primary care provider (PCP) or primary care clinic (PCC) at enrollment. Otherwise, Quartz will assign a primary care clinic near your home.

- Family members can choose different providers and clinics.
- When you receive your member ID card, please confirm the right PCC is listed.
- You can choose a new PCP or PCC at any time, just update your account in MyChart (QuartzMyChart.com) or call Customer Success at (844) 644-3455.

- You don't need a referral to see an in-network provider.
