See what's new at Quartz

Open enrollment is just around the corner, and we're here to help you prepare. Below is a quick overview of what's changing for the Quartz UW Health Network in 2027, along with resources to help you review your options and make informed decisions during enrollment.

What to know for 2027

- Open enrollment runs from October 5 – October 30, 2026.
- To change your plan or enroll in a new plan, visit the new My Insurance Benefits portal at apps.etf.wi.gov/MemberPortalWeb.
- For State non-Medicare plans, Local P06/P16 plans, and Access plans, the annual medical deductible will be \$400 individual/\$800 family, the medical out-of-pocket limit will be \$1,400 individual/\$2,800 family, and the emergency room copay will be \$125.
- For all HDHPs, including the Access HDHP, the combined medical and pharmacy deductible will be \$2,000 individual/\$4,000 family, the combined out-of-pocket limit will be \$3,500 individual/\$7,000 family, and the emergency room copay will be \$125 after the deductible.
